Mahbhuta Yoga Festival, LLC; reserves the right to deny any application without explanation. 5. All exhibitors and assistants must follow Mahabhuta Yoga Festival Vendor Rules & Regulations. 6. Vendors may use the space they have rented ONLY. Extending beyond the boundaries of your rented space could result in additional fees and/or expulsion from the Festival. 7. The Mahabhuta Yoga Festival name and logo are registered trademarks. No product or service bearing the Mahabhuta Yoga Festival name or logo -- or the name or logo of any of its sponsors-- may be sold or marketed in any manner without prior written consent from the Festival or the sponsor. 8.
